The lie just got bigger. You have to be 18 to take the GED test. Amanda Lollar states she took it and passed at age 15.

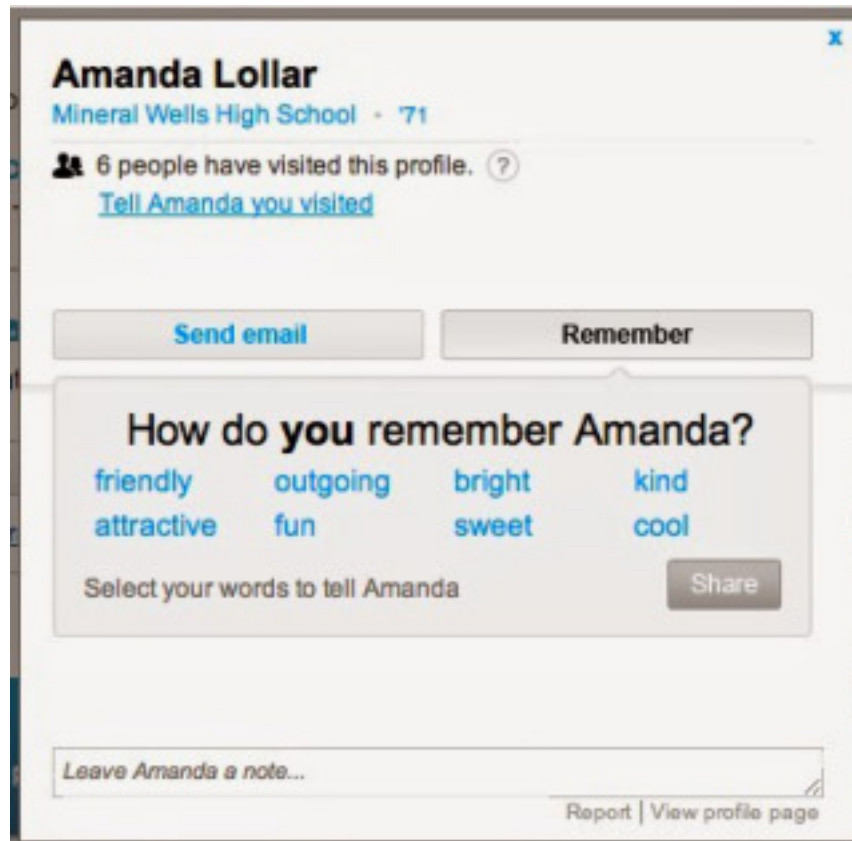
